Matters arising from previous minutes	No matters arising.
Chairman's report	2013 was another good year with 900 to 1000 riders at our trial. We did cancel the Xmas trial at the end of 2013 because of the weather conditions.
	We ran 7 club trials, March hare, Euro cup, Brit bike trial and 2 practice days. We also had a stand at Telford.
	The Euro cup was again a successful event with 100 riders per day. Which included a reasonable overseas entry.
	We are planning a full program of events for 2015. To include the March hare 1 <sup>st</sup> March, Euro cup Weekend July 4 <sup>th</sup> and 5 <sup>th</sup> and Telford
	We again held our Dinner dance to thank landowners, we had between 80 and 90 attendees.
	I would like to thank the Landowners and observers and helpers for their continued support in 2014.
	The Chairman ended his report by repeating his thanks all the committee, the landowners and everyone else that helped to ensure the club ran successful events during 2014.
Treasurers Report	<ul> <li>2014 balance presented.</li> </ul>
	Income £17,378.50 (2013, £17,418.50) of which the entry fees were slightly down for a second year at £13,720 but as we have increased the cost of entries this meant the entries were almost the same as last year even with the cancelled Xmas trial.
	Expenditure £19,246.06 (2013, £16,499.06) which was up on the previous year, we have increase fees for using land and observers gifts as well as the purchase of the defibrillator and additional donations to charity. We did save on the payment to the AMCA because of the cancelled Xmas trial

	We had an overall a loss in 2014 of £1867.83.
	The bank balance at December 2014 was $\pounds 22,473.34 + \pounds 13$ in hand compared to $\pounds 24,263.16$ at December 2013.this included $\pounds 91.01$ which could not be reconciled.
*	Assets at December 2014 were valued at £4,500 inclusive of a nominal 10% write down. (2013 was £4,651)
×	Dave asked for questions: There were none
	Dave noted we had purchased the defibrillator and also made payments to TT rides charity in the memory of Bob Price who died at the 2014 Isle of man TT, also Meningitis trust and the Air ambulance. We had also lost the money for the awards vouchers we purchased at BVM when they shutdown. We have purchased new vouchers, and hope to recover the money for the old vouchers in full.
	Dave then said this would be his last year as Treasurer as Rik Lees had shown an interest in taking on the treasurers roll and Dave felt this would be a good time to hand over the reins. He thanked everyone for the support in his period as treasurer.
